- 2. Spring Tournament Update everything is getting ready to go.
- Awards Night Update February 28, 2015 is booked at Golden Ears Curling Club.
  Roxanne is going to get an announcement on the website. Run it by donation only and
  will have some food trays.
- 4. Sponsorship Update Golf sponsorship draft was sent to Kyla. Bruce thinks they need a meeting with Scott, Derek G., Bruce and maybe someone else to have a brainstorming session about the golf tournament vision.
- 5. **Motion** to approve payables in the amount of \$87,972.99 Carolyn Seconded by Blaine. **Carried**
- 6. Respect Desire Pride in the last 3 weeks pretty much every day Scott has received a notice about suspensions or misconduct from PCAHA and/or BC Hockey by our members, players, parents, coaches, etc. Many issues have been dealt with by Scott with either Derek G. or Blaine depending if it's a C or A team issue. Scott is especially concerned about players using racial or homophobic slurs.
- 7. James Eccles BC Hockey James has been approached to be on a coaches committee with BC Hockey.
- 8. Awards for this Season Derek G., along with others, feels that we should streamline the awards. New awards have been decided on for this season and Derek G. will go ahead and have the coaches give their nominations.
- 9. Budget and Registration Rates for next season discussion about budget as proposed. Rates proposed for next season discussion. Jersey rental fee Roxanne proposed

that Hockey 1 to 4 Rental fee be \$25. Derek B. pointed out that rates haven't changed for quite some time and ice rates alone rise by approximately 5% per year. Institute a late registration fee for payment after July 1 and another late fee for registration after September 1 for instance. We would still keep the third child in a family half price discount. **Motion** to approve the rates for the 2015/16 season – Carolyn – Seconded by Lisa. **Carried Motion** to approve the budget for the 2015/16 season – Carolyn Seconded by Roxanne. **Carried**

- 11. Ice Coordinator Kelli would like to continue as Ice Coordinator for next season. She has requested an increase to \$6,000.00 which is included in the budget. **Motion** to approve Kelli Semple Borkowsky as the Ice Coordinator at a fee of \$6,000.00 for next season Nolan Seconded by Derek G. **Carried**
- 12. Equipment Room need to get together as a Board to tidy up the room before the jerseys start coming back at the end of the season. Blaine suggests we pick a date to go in and get it cleaned up. Autumn and Teena would like to be a part of this.
- 13. Board Meeting move the March 16 meeting to Sunday, March 22
- 14. AGM Possible Dates Wednesday, March 25 is first choice with Tuesday, March 24 being the back-up date at Thomas Haney Rotunda.
- 15. Guidelines/Registration Info for next season Roxanne wants to communicate more information to members or potential members. No special time requests, no coach requests, etc. should be communicated.
- 16. Clarification of Protecting Team Officials nothing in the policy manual to show whether coaches can "protect" a player in order to keep an assistant coach or other team official. Discussion.
- 17. Spring tournament thank you ad to businesses who have donated items on Tournament webpage.
- 18. PCAHA President's meeting tomorrow night Derek G. will attend in Scott's place as he is unable to attend.
- 19. Spring Development Program Scott and James have met to go over the proposed programming for Spring development including the instructors and number of them. If we were to charge \$25 per athlete for the sessions and we completely sold out we would net approximately \$9,900.00. At \$20 per session we would net approximately \$5,000.00.

#### **GUIDELINES / REGISTRATION INFO FOR NEXT YEAR**

I'm getting lots of inquiries about registration opening date for next year and also inquiries as to times / coaches, so the sooner we put this out there, the longer parents have to absorb it.

Furthermore I would like to clarify the "protecting" of an assistant coach - I don't see it anywhere in the policy manual and we had two instances this year where a head coach didn't protect an assistant, but then protected a manager in order to keep a certain player on their team. Right now there is nothing about protecting an assistant coach, so it either needs to be added (and clarified that this ONLY pertains to a coach and not another team official such as a manager or safety) and also post this sooner than later to the website registration page.
