25mins	2	Parent Survey Report Recap and comments (report sent out April 4th)- Dave L Dave will send out follow up to all our members this week. Here is Dave's revue  1. Participation: _267 Participants = 25% response rate.  - Atom A&C and Novice Divisions making up just under 40% of participants  - Division participation declines as athletes get older, but significant feedback in the higher divisions from A hockey; with 37% of survey responses from A and 63% from C hockey.  - 9 families asked to be contacted. I will follow up.  2. Development: _Satisfaction rates are generally high with an average of 84% or higher satisfied in most areas of development; with the exception of specific direction of the development sessions. We also heard some concern about group sizes and a desire for more position specific development.  - Recommendation — Along with the lead developers, build a season-long development plan in each division. For example, areas of growth such as skating and puck movement at lower levels and 'game like' compete drills throughout the divisions. Position-specific development will also be addressed and mapped out for the 2020-21 season as well. All BTA and MGA teams rotate through their development times individually and need to work with coaches at the lower divisions to structure ice times with larger groups. Using three zones of 8-10 skaters per ice time, etc.  - 3. Culture: _Very positive with high ratings of 91% or greater on feeling valued, recognizing RMMHA's core values, feeling respected by team difficials and over 90% of the responders believing that the association is heading in the right direction.  - However, despite this, over 26% would not recommend their coach for a coaching position next season. This is an increase of almost 10% from the previous season, which suggests we need to focus on coach development.  - Recommendation — Despite high culture grades, there is a gap when it relates to coaches and coach support. My suggestion would be to enhance coach development but with respect to on-ice
