## New Process Effective Jan 2023 ICE ALLOCATION







## Game Schedule

Advise the Ice Coordinator of all conflicts with games <u>and</u> practices, including future tournament dates so that ice can be reallocated.





## Game Schedule

The Ice Coordinator will be using schedules posted online (Spordle/ formerly HiSports) to confirm conflicts. Advise your League Manager ASAP if the online schedule is not up to date or has any errors (as well as the Referee Assigner if the game is upcoming).





## Ice Conflicts

The current process of Returning, Booking, and Holding Ice will <u>no longer be implemented</u>.

You may continue to use the same process to notify me of Ice Trades (both teams must be included on the email).







## **New Process - Communication**



Advise the away team of the new game time. This must be done as soon as possible so that the time can be offered to another team if the replacement time is not accepted.

If both teams are RM, I will email both managers at the same time with a replacement game time.

> When the opposing team accepts the new game time, confirm with the Ice Coordinator, then advise the Referee Assigner (Bantam C and below teams) and the League Manager of the old and new game date/time/location. Confirm that the online schedule has been updated with the new information.







## Reallocation

Once you turn in any game or practice conflict time, it will be reallocated to another team. Teams may not turn in an ice time and then try to trade it with another team.





## Early AM Practices

Early morning practice ice scheduled the day of or the day after a league game is not considered to be a conflict. Please try to switch your early morning practice with another team from the same division. If you cannot make a trade, you must turn in the ice time, and I will try to offer another time if available.





## **Special Events**

There will be occasions where our ice has been taken away for other special events, either hosted by us or another user group. In these cases, you may not be given any replacement ice for your practice.

## One Referee or No-Show Ref

Hockey Canada Rule 5.2:

(k) If, for whatever reason, the Referee or Linesmen appointed are prevented from appearing, the Managers or Coaches of the two competing clubs shall agree on a Referee and one or two Linesmen. If they are unable to agree, they shall appoint a player from each team who shall act as officials.





## Hockey Canada Rule 5.2

(I) If the regularly appointed officials appear during the progress of the game, they shall replace the temporary officials immediately.

(m) If a Linesman appointed is unable to act at the last minute, or if through sickness or accident she is unable to finish the game, the Referee in charge shall have the power to appoint another in her place, if she feels it necessary.





## Hockey Canada Rule 5.2

Remember that conflict ice is taken from your team and exchanged with another team's ice time that they are unable to use. If you are assigned a game time, and that game is not played because no refs show up, that ice time is now lost and cannot be used by another team. Your team now has an extra ice time assigned to you. This makes it difficult to find a second ice time to schedule that game if it is not played.





#### Home Game Times

If you do not have a league game scheduled on your regular home ice time, due to a scheduling week/break, your team will normally be able to keep that ice time to use as a practice or exhibition game. During special events, this ice time may be needed. Please *do not schedule* any exhibition games on your home ice during a scheduling break without checking with me first.
