ELECTION OF BOARD OF DIRECTORS

POSITIONS UP FOR ELECTION FOR 2023/24 SEASON:

- VP of 'A' Hockey (2yr commitment)
- VP of 'H' Hockey (2yr commitment)
- 4 x Two-Year Director-at-Large Positions
- 1 x One-Year Director-at-Large Position

Current* Director-at-Large roles that will be open are:

- 1. Treasurer
- 2. Volunteer Coordinator
- 3. Tournament Director
- 4. Sponsorship Director
- 5. Secretary/Communications Director

Please review these provisions prior to the AGM:

- One or two year Director positions are elected as "Directors at Large" and the Executive Group will decide which role each Director will fill. You are not running for any specific Board roles.
- Only named roles (ie. President, VP's of Admin / C / A / H) are specifically elected into those roles.
- RMMHA <u>Bylaws</u> identify in Part 2 Membership, who is eligible to be Ordinary, Contributing, or Life Members. Furthermore, Part 4.11 identifies who is eligible to vote at the AGM.
- As per the 2022 AGM, nominations for directors must be received NO LATER than 7 days prior to the AGM (by March 21 at 11:59pm). When there is a candidate already previously nominated for a position at the AGM, no other nominations will be accepted from the floor. (Bylaws Section 18.4).
